## ***Youth Summer Day Camp 2019***

Children who live or vacation in Harpswell are invited to participate in the Summer Program at the Fulle Field (Tennis Courts), Harpswell Center, next to the Kellogg Church. All children who have completed Kindergarten through the sixth grade are eligible to participate. The Program begins July 1 – July 26, 2019

½ day program M-F from 9am to 12 pm. M-F Full Day 9am – 3pm. Space is limited.

Every day, children will participate in supervised outdoor games, tennis lessons, and arts and crafts. Some weeks may include Zumba, yoga, wood building activities and Chewonki's traveling natural history program. Special theme days are also part of our program and may include a trips to the beach at Mitchell Field, Gray Animal Park, bowling alley, movie theater, Eagle Island, or an Orr's Island noon cruise, or the ever-popular Tie- Dye Day, and, everyone's favorite, Christmas in July.

Debb Cornish, for the 21st year, will continue her position as Camp/Program Director and will be joined again by our professional tennis instructor Marta, celebrating her 10<sup>th</sup> year on board, and other trained and experienced staff. The primary aim of HNPEA is to provide an affordable enriching program that builds campers self-confidence through exposure to the arts, recreational activities, and Maine Heritage. By taking advantage of Harpswell's extensive coastline and wooded trails, the program also seeks to heighten children's awareness of the environment in which they live. It aims to emphasize healthy lifestyles not only through physical activity, but also through learning about the benefits of (and enjoying) good nutrition.
